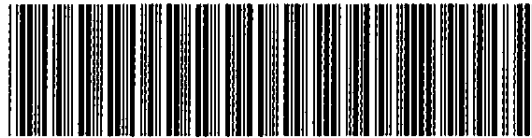

ARTICLE II - Address

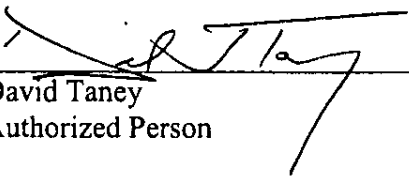

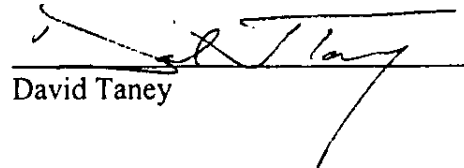
