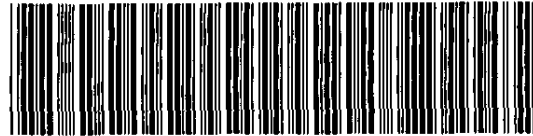

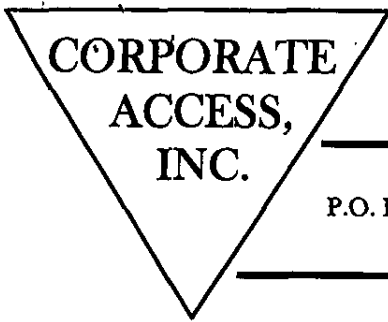


ARTICLE IV – MANAGEMENT


