ARTICLES OF ORGANIZATION

OF

MOM MOM'S GOURMET FOODS, LLC

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

1. Name.

The name of the limited liability company is MOM MOM'S GOURMET FOODS, LLC (hereinafter referred to as the "LLC").

2. Effective Date.

The date of the commencement of the LLC existence shall be the date of the Hing of these Articles with the Secretary of State.

3. Period of Duration.

Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the LLC shall be perpetual.

4. Purpose.

The purpose for which the LLC is organized is to engage in any and all business and activities permitted by the Act and any other applicable laws of the State of Florida. The LLC shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

5. <u>Units of Ownership.</u>

This LLC is authorized to issue 1000 units of ownership at no par value.

6. Address Of Place Of Business.

7. Registered Agent.

8. Capital Contributions.

Contributions to the capital of the LLC shall be made by the members, in the manner prescribed by the written Operating Agreement made and entered into by the members and which may be amended from time to time in accordance with its terms.

9. Members.

The LLC shall have at least one member and may admit additional members on the prior unanimous written agreement of the then-existing members, or as otherwise provided in the Operating Agreement.

10. Continuity of Business.

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the LLC, or upon any other event that, under the Act, would result in dissolution of the LLC, the business of the LLC may be continued and the LLC will not be dissolved withou prior written consent of all the remaining members of the LLC.

11. Management.

The overall management and control of the business and affairs of the LLC shall be vested in its members, as provided in these Articles of Organization and section 602 407 of the Act. Any and all action by the LLC shall require the vote of members holding a majority atterest in the LLC.

12. Indemnification.

Except as expressly provided in the Operating Agreement, the LLC shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.
