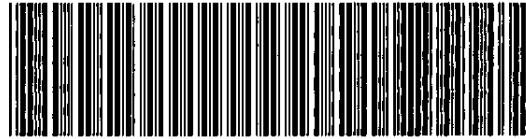

**ARTICLES OF ORGANIZATION  
OF  
MUSICALLY OVERJOYED, LLC**

The undersigned, as the authorized representative of the initial members of the captioned limited liability company which is being formed under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes (the "Act"), hereby files the following Articles of Organization:

**ARTICLE I**

**Name**

The name of the limited liability company is MUSICALLY OVERJOYED, LLC (the "Company").

**ARTICLE II**

**Address**

The Company's current mailing address and street address of its principal office shall be 1005 Bent Road, Tampa, Florida 33612.

**ARTICLE III**

**Registered Agent**

Once so adopted, any amendment to or repeal of the Operating Agreement shall be undertaken only by those person(s) and only in the manner prescribed therein.
