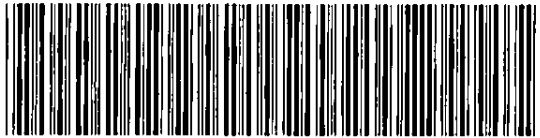

Pursuant to the provisions of Section 605.1025 of the Florida Statutes, the undersigned hereby adopt the following Articles of Merger:

ARTICLE I – Names of Merging Parties

The name of the merging party is LEWIS GENTRY HOLDINGS, LLC, a Delaware limited liability company [Delaware document no. 6625221] (“Lewis Gentry Holdings”).

ARTICLE II – Name of Surviving Limited liability company

The name of the surviving limited liability company is ORLANDO AIRCRAFT INVESTMENTS, LLC, a Florida limited liability company [Florida document no. L11000049408] (“Orlando Aircraft Investments”).

ARTICLE III- Approvals
