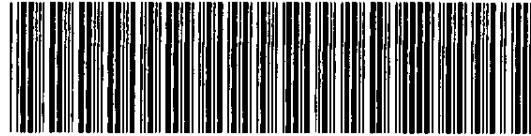

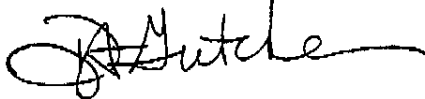
Dear Gina,

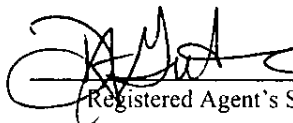

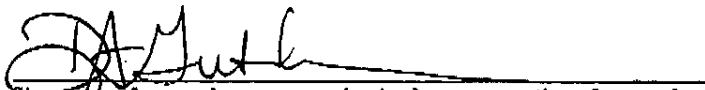
