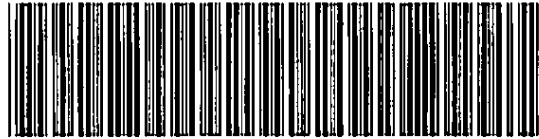



Pursuant to Florida Statutes 605.0202 of the Florida Limited Liability Company Act, the undersigned limited liability company adopts the following Articles of Amendment to the Articles of Organization.

1. The name of the limited liability company is Baroque Equestrian Games, L.L.C.
2. The Articles of Organization of the company were filed with the Secretary of State of the State of Florida on April 28, 2011 and assigned document number L11000051273.
3. The following amendments to the Articles of Organization were adopted by the sole Members/Managers of the company by unanimous vote on February 21, 2022, in the manner prescribed by the Florida Limited Liability Company Act:

4. Article 1, Name, is amended as follows:

Name. The name of the limited liability company shall be **NEW DAWN EQUESTRIAN L.L.C.**


5. Article 5, Purposes and Powers, is amended as follows:
