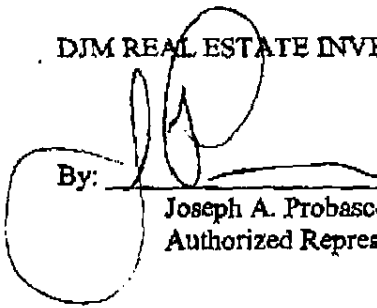
1. The Company's Articles of Organization are hereby amended by adding the following form of Article VII:
