Dear Renee,

Please find this to be my formal resignation from The Quad Squad DBA On The Grow Again. In light of recent events I find it suitable at this time to no longer associate myself with the business and wish for this letter to serve you as my formal resignation.

In the appearance of the numerous emails and text messages that you have sent out, you have taken the roll of acting managing partner and assuming 50% of the roll of the company. I, Virginia Cearra, sent a text message to Renee Munro dated January 7, 2012 at 11:57 am stating that we needed to get together to get our taxes started and sit down and discuss everything. I received a text back on January 12, 2012 at 6:09am from Renee Munro stating that she was too busy and it would have to wait until after mid February. I, Virginia Cearra, sent another text on January 23, 2012 asking if I could go ahead and pick up the documents from Renee Munro for the taxes to get them started. At this time Renee Munro sent an email to onthegrowagain@yahoo.com stating that she could not hand over On The Grow Again's financial documents and that again the taxes would have to wait until after February 20th, 2012 when she had time to do them. I, Virginia Cearra, sent another email dated January 24, 2012 stating that we as a group needed to get together between January 24, 2012 and February 5, 2012 to do the taxes so we did not have any penalties. Renee Munro sent an email dated February 1, 2012 at 12:18pm stating that she was speaking on behalf of Kristen Vangorder and that Renee and Kristen could meet on Friday February 3, 2012. I, Virginia Cearra, responded on February 1, 2012 at 12:18pm stating that I already had plans for that Friday and would not be available but could do it Thursday, Saturday or Sunday. Crystal Schauer sent an email on Feb 1st at 8:06pm stating that it seemed like it was going to be hard to get all of us together and that Marc, the accountant who had helped us get the business started, was willing to do our taxes free of charge and would just like to get the documents to him so he could start the taxes. Renee Munro responded on Friday February 3, 2012 at 8:49am stating that she was speaking on behalf of Kristen Vangorder again and she did not feel comfortable letting Marc look at On The Grow

Again taxes and she would have to think about it and get back to the group. After going back and forth Virginia Cearra and Crystal Schauer agreed to let Renee Munro pick the tax professional since she would not hand over the company documents. I, Virginia Cearra, have been trying to get the name of the tax professional since Sunday February 5, 2012 from Renee Munro and she is refusing to give it to me.

As you can see above Renee Munro has been acting on behalf of herself and Kristen Vangorder with no response from Kristen on and documents and Renee Munro has been acting as the managing partner of The Quad Squad DBA On The Grow Again. I would like for all the documents above to show proof that she has been acting as owner of 50% of the business when there are 4 partners involved, and withhold documents for all partners to see, making her the acting managing partner.

Renee Munro will be responsible for all future filings on the business including Form 4797 for the sale of all goods of the business. The clothing racks and merchandise scanner are available for pick up for sale by appointment at 522 Balcom Ter Se Palm Bay, FL 32909. Under Florida law I am entitled to receive, within a reasonable time after withdrawal, the fair value of his interest in the LLC as of the date of this resignation based upon my right to share in distributions from the LLC.
