**ARTICLES OF ORGANIZATION
OF
CENTER ROAD PROPERTIES, LLC**

The undersigned person, acting as the organizer of CENTER ROAD PROPERTIES, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is:

CENTER ROAD PROPERTIES, LLC

ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE

The existence of the company will commence on the date of filing. The Articles of Organization are filed with the Florida Department of State, and the existence of the company shall be perpetual.

ARTICLE III - PURPOSE

The company may transact any or all lawful business. As a limited liability company may be organized under the Florida Limited Liability Company Act.

ARTICLE IV - INITIAL REGISTERED AGENT AND OFFICE

ARTICLE VIII - REGULATIONS

The company shall not be dissolved upon the death, resignation, expulsion, bankruptcy, or dissolution of a member.

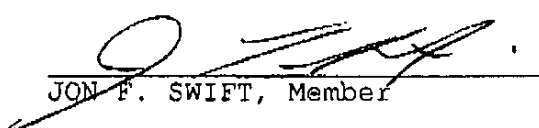
