The name and address of the Managing Member of the Limited Liability Company remains the same:



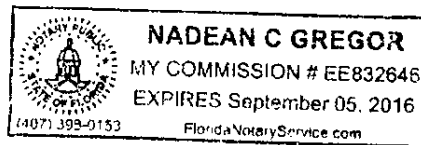
