# ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF ATCF II FLORIDA-C LLC

ATCF II FLORIDA-C LLC is a limited liability company formed by the filing of the Articles of Organization on May 4, 2011 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Initial Articles") with the Department of State of the State of Florida.

The limited liability company hereby amends the Initial Articles by adding the following Article XI immediately after Article X set forth therein:

#### ARTICLE XI

Notwithstanding any provision hereof to the contrary, the Company shall have the authority to incur indebtedness under a warehouse credit agreement entered into with Security Benefit Corporation, as administrative agent and collateral agent, and the Company shall have the authority to grant liens in connection therewith, so long as (i) the proceeds of such indebtedness are used to repay in full all outstanding obligations of the Company (other than contingent indemnification claims that have not been asserted) under the Credit Agreement entered into as of May 22, 2012 among certain Alterna Companies, including the Company and CONA (ii) such indebtedness is incurred on or before May 21, 2015, and (iii) CONA shall have received such payment in full of all Alterna Companies' outstanding obligations with CONA not later than May 22, 2015.

Except as expressly set forth herein, no other changes or modifications to the Initial Articles are intended or implied. In the event of a conflict between the terms of these Articles of Amendment and the Initial Articles, the terms of these Articles of Amendment shall control.
