
Pursuant to the provisions of Section 608.411 of the Florida Statutes, the undersigned limited liability company hereby adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is JOBELPA USA, LLC (the "Company").
2. The Articles of Organization of the Company were filed on May 4, 2011, and assigned Florida Document No. LI1000052836.
3. The Articles of Organization are hereby amended by adding the following additional Article V:

ARTICLE V

The original capital of the Company being \$1,000.00, as indicated in the Company's Operating Agreement, was increased by \$12,052,721.52 on August 1, 2012, resulting in a total capitalization of \$12,053,721.51 owned by Jobelpa S.A., a Brazilian corporation.
