Principal Office and Registered Agent

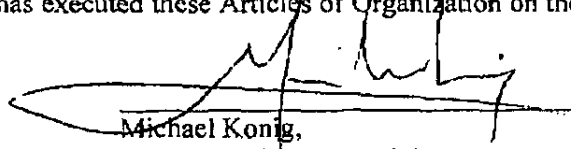
