**ARTICLES OF MERGER OF
ROSSI INVESTMENTS, L.L.C., a Florida limited liability company
WITH AND INTO
ROSSI DEVELOPMENT, LLC, a Florida limited liability company**

Pursuant to the provisions of Section 605.1025 of the Florida Statutes, the undersigned hereby adopt the following Articles of Merger:

ARTICLE I – Names of Merging Parties

The name of the merging party is Rossi Investments, L.L.C., a Florida limited liability company [Florida document no. L05000035869] (“Rossi Investments”).

ARTICLE II – Name of Surviving Limited liability company

The name of the surviving limited liability company is Rossi Development, LLC, a Florida limited liability company [Florida document no. L11000053218] (“Rossi Development”).

ARTICLE III- Approvals




