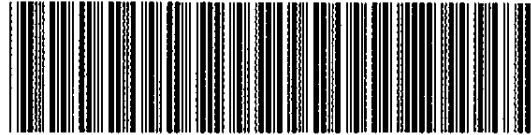



7. This Certificate of Conversion and the attached Articles of Organization shall be effective as of the date of filing.




