The undersigned, JAMES W. HARRIS, a natural person competent to contract and member of JIM HARRIS INSURANCE, LLC, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, *Florida Statutes*.

ARTICLE I

The name of the limited liability company is:

ARTICLE VI - MANAGEMENT


The Company shall be managed by its members as provided in the Company's Operating Agreement. The name and address of the initial member are as follows:


