

ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, hereby adopts the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is **FOGGY BOTTOM LAND AND CATTLE COMPANY, LLC**.

ARTICLE II

ADDRESS

The principal office and mailing address of the limited liability company shall be 339 Adams Lane, Orange Park, Florida 32073.

ARTICLE III

DURATION

The duration of the limited liability company shall be fifty (50) years, and shall commence on May 1, 2011.

ARTICLE IV

MEMBERS AND MANAGEMENT

The initial member of the limited liability company is Albert L. Mize, Jr., who shall manage the limited liability company in accordance with an Operating Agreement to be adopted by such member.

ARTICLE V

ADMISSION OF ADDITIONAL MEMBERS

ARTICLE VI

MEMBERS' RIGHTS TO CONTINUE BUSINESS

The remaining member(s) of the limited liability company shall have the right to continue the business on the death, retirement, resignation, expulsion or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, provided each remaining member consents thereto in writing.

ARTICLE VII

INITIAL REGISTERED OFFICE AND AGENT


