- FIRST:** The name and address of this Company is **TRANSBRAZIL RENT A CAR, LLC**, 1111 Southwest 1st Avenue, #123, Miami, Florida 33130.
- SECOND:** The Articles of Organization were filed on May 6, 2011 and assigned document number L11000054066.
- THIRD:** The date of the adoption of these Articles of Dissolution is 10 November 2015.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members.
