The name of the Limited Liability Company is "**Lyme Technology, LLC**" (the "**Company**").

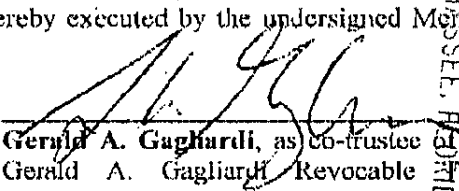

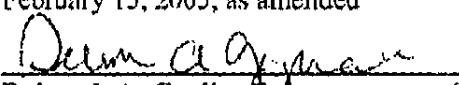
