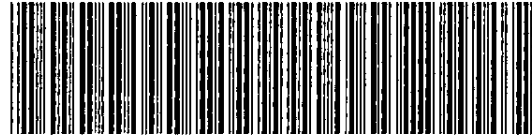

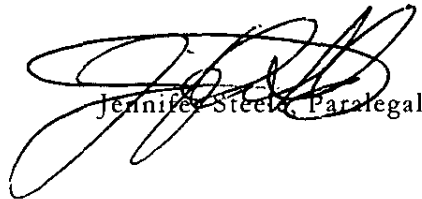

1. **Name.** The name of the limited liability company is Dexter's of Thornton Park Properties, LLC.
2. **Purpose.** The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.
3. **Address of Principle Office.** The address (street address) of the registered office of the limited liability company is 558 W New England Avenue, Winter Park, Florida 32789. 4. **Term.** Term of this LLC shall be perpetual.
