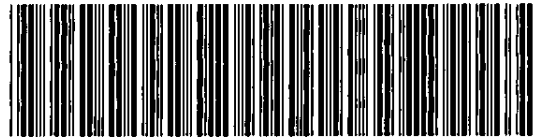

3. The number of votes cast for said amendment was sufficient for approval.


