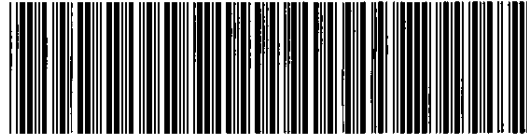



ARTICLE I


The name of this limited liability company is: TEK TANGO, LLC.
