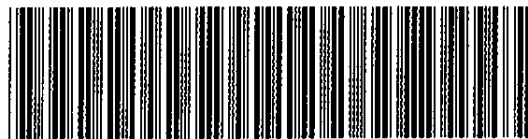

**ARTICLES OF ORGANIZATION OF  
ORANGE CITY FUNDING, LLC**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purposes of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. Name. The name of the Limited Liability Company is Orange City Funding, LLC (the "LLC").

2. Period of Duration and Effective Time. The LLC shall have perpetual existence commencing at 12:01 a.m., May 11, 2011, or until it is dissolved and its affairs wound up pursuant to the provisions of the Florida Limited Liability Company Act.
