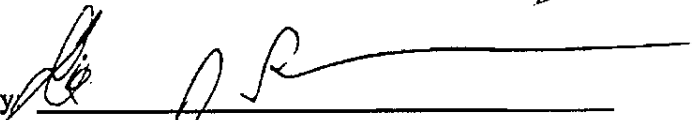
1. These articles of correction correct the Articles of Organization filed with the Department of State on May 11, 2011.
