ARTICLES OF ORGANIZATION

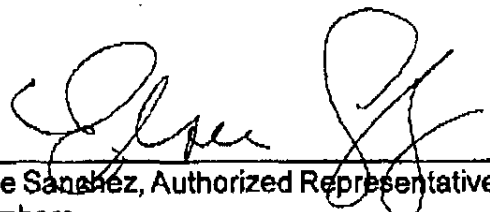

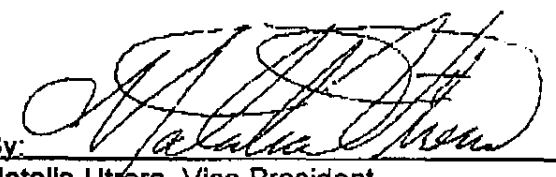
