

**ARTICLES OF AMENDMENT TO AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
OF  
SAS CHELSEA PARK AT METROWEST MANAGERS, L.L.C.**

The undersigned, as the Sole Member of **SAS CHELSEA PARK AT METROWEST MANAGERS, L.L.C.**, a Florida limited liability company (the "Company"), desiring to amend the Amended and Restated Articles of Organization of the Company pursuant to the terms of Chapter 608, Fla. Stat., the Florida Limited Liability Company Act, states as follows:

1. The current name of the Company is SAS CHELSEA PARK AT METROWEST MANAGERS, L.L.C.

2. The date of the filing of the Amended and Restated Articles of Organization of the Company was May 18, 2011.
