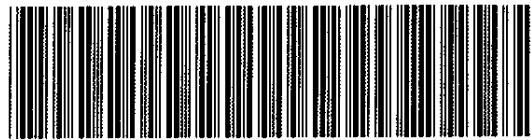

of

(A Florida limited liability company)

1. The name of this limited liability company is Brickell Research & Trading LLC (the "Company").




