ARTICLE IX - LIMITATION OF DIRECTOR'S LIABILITY

A manager, director or officer of this company shall not be personally liable to the corporation or its stockholders for money damages for breach of fiduciary duty, except to the extent such exemption from liability or limitation thereof is not permitted under the Florida limited liability companies' law. If the said law is amended after approval by the owners of this article to authorize company action further eliminating or limiting the said personal liability, then the liability of managers, directors or officers of the company shall be eliminated or limited to the fullest extent permitted by applicable Florida or general law, and as amended from time to time without further action by the owner/members.

Any repeal or modification of this Article shall not increase the personal liability of any director, officer or manager of this company for any act or occurrence taking place prior to such repeal or modification. The provision of this Article shall not be deemed to limit or preclude indemnification by the company for any liability of a director, officer or manager which has not been eliminated by the provisions of this article.
