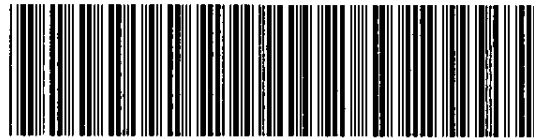

P.A.M. INTERNATIONAL 2011, LLC.

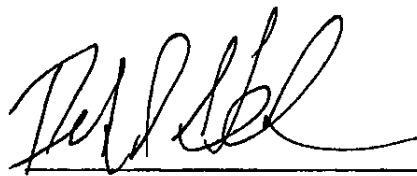
ARTICLE II
