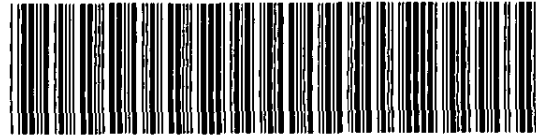

#### **Article VI – Limitation on Agency Authority of Members**




