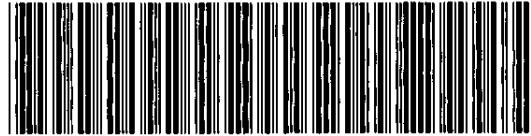

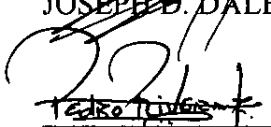
## ARTICLE VIII
