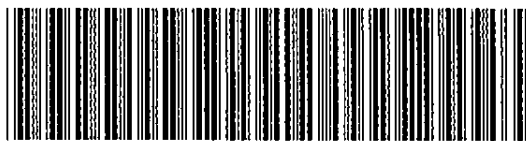

ARTICLES OF ORGANIZATION

OF

ICOH GROUP, LLC

Article 1. Name. The name of the Limited Liability Company is ICOH GROUP, LLC (hereinafter the "Company"). The Company is organized under the State of Florida Limited Liability Company Act, O.C.G.A. Section 14-11-100 et seq.

Article 2. Registered Office and Agent. The initial registered office of the Company shall be at 5350 Devron Drive, Jacksonville, Florida 32209, and the initial registered agent at such address shall be Evelyn Peters-Washington.

Article 3. Principle Place of Business. The Company's initial principle place of business shall be located at 5350 Devron Drive, Jacksonville, Florida 32209.

Article 4. Indemnification. No member or manager shall have any personal liability to the Company for monetary damages for breach of duty or care or other duty as a member or manager and the Company shall indemnify the members, managers, and agents of the Company from and against any and all claims and demands whatsoever arising in connection with the Company except that such persons shall be liable for and may not be indemnified for (a) intentional misconduct or a knowing violation of law; or (b) any transaction for which the person received a personal benefit in violation or breach of any provision of the operating agreement agreed to by the members of the Company; or (c) as otherwise limited by the Florida Limited Liability Company Act.

Article 5. Approval Rights of Members. Except as otherwise provided in a written operating agreement, the vote or consent of the members set forth in subsection (b) of O.C.G.A. Section 14-11-308.

Article 6. Officers:

Glenn Mitchell – DIRECTOR-MANAGER

Rodrick Wayne PETERS-DIRECTOR-MANAGER

Jack Diamond – CEO-MANAGER

Officers shall be elected by majority member vote and serve for a two-year term.

Having been named as registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, F.S..

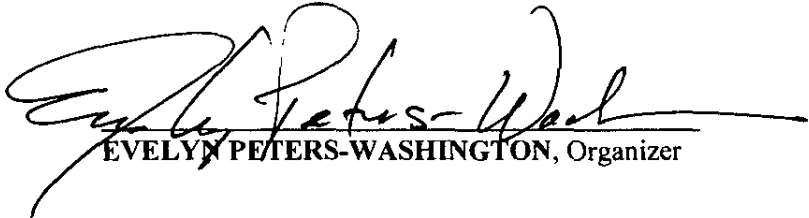
