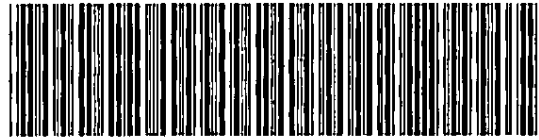

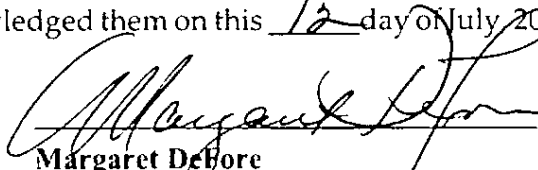

The foregoing amended and restated Articles of Organization were adopted with the unanimous consent of all members.

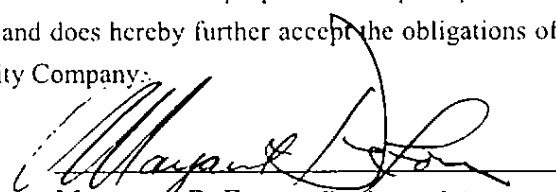
