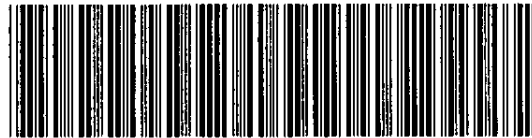

ARTICLES OF ORGANIZATION OF A  
FLORIDA LIMITED LIABILITY COMPANY
