TO

SECOND: The Articles of Organization were filed on May 23, 2011 and assigned Florida document number L11000060634.

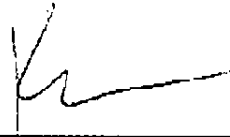
THIRD: Article I of the Company's Articles of Organization is hereby amended to read in its entirety as follows:
