

# ARTICLES OF ORGANIZATION

OF
MSR ORLANDO, LLC

The undersigned hereby certifies that these Articles of Organization have been prepared and are being filed for the purpose of establishing a limited liability company under the laws of the State of Florida, and to provide for the formation, rights, privileges and immunities of Angited liability companies for profit.

#### ARTICLE I

#### Name and Principle Place of Business

The name of the limited liability company shall be MSR ORLANDO, LLC, and its principal office shall be located at 95 Mural Street, Suite 600, Richmond Hill, Canada L4B 3G2, and office shall be located at 2570 Dwyer Lane, Lake Mary, FL 32746, but it shall have the power and authority to establish offices at any other place or places as the members may designate.

#### **ARTICLE II**
