ARTICLES OF ORGANIZATION
OF CITRUS HILLS HOLDINGS, LLC
(a Florida Limited Liability Company)

The undersigned authorized representative of the members pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby submits the following Articles of Organization:

ARTICLE I - NAME: The name of this Limited Liability Company shall be Citrus Hills Holdings, LLC (the "Company").

ARTICLE II - MANAGEMENT - The initial manager of the Company is Stephen A. Tamposi.



ARTICLE V - ADDRESS: The mailing address and street address of the principal office of the Company is 2476 North Essex Avenue, Hernando, Florida 34442.


