Principal Office

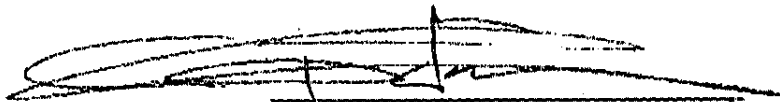
