**ARTICLES OF ORGANIZATION FOR  
ANDRES CARBUNARU, D.D.S., P.L.**

**a Florida Professional Limited Liability Company**

The undersigned, in forming a Florida Professional Limited Liability Company ("Company") under the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Organization for such Company.

**ARTICLE I - NAME**

The name of the Company is ANDRES CARBUNARU, D.D.S., P.L.

**ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Company is 2235 N. Commerce Parkway, Suite 1, Weston, FL 33311-1355.

**ARTICLE III - PURPOSE**

The Company is organized for the purpose of engaging in the business of rendering professional dental services in the State of Florida by and through the Company's members, officers, employees and agents, as those terms are used in Section 621.06 (or successor legislation), Florida Statutes, who are duly licensed or otherwise legally authorized to practice dentistry in the State of Florida, and transacting any and all other lawful business that the company may engage in under Chapter 621, Florida Statutes, as may be amended from time to time, including investing the funds of the Company in real estate, mortgages, stocks, bonds, or any other type of investment, or owning real or personal property necessary for the rendering of said professional dental services.

**ARTICLE IV - DURATION**

The period of duration for the Company shall be perpetual.

#### ARTICLE V - MEMBER UNITS

The Company is authorized to issue 10,000 Units of membership interest, which Units shall evidence the interest of the members of the Company, which Units shall be designated "Member Units." The interest of the members of the Company shall be evidenced by the Certificate of Company Units issued by the Company and setting forth the number of Member Units issued and outstanding in the name of such member.

#### ARTICLE VI - MANAGEMENT

6.1 The Company has a board of managers and the business and affairs of the Company shall be managed by or under the direction of its board of managers. No member of the Company, in such capacity as a member, shall have any right or authority to act for or to bind the Company.

6.2 The board of managers of the Company shall consist of one (1) manager initially. The number of members of the board of managers may be either increased or diminished from time to time as provided in the Regulations of the Company but shall never be less than one (1). Each manager shall serve until the first annual meeting of the members of the Company or until their successors are elected and qualify.
