The undersigned, for the purpose of forming a limited liability company under the Florida Limited Company Act, Florida Statutes Chapter 606, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

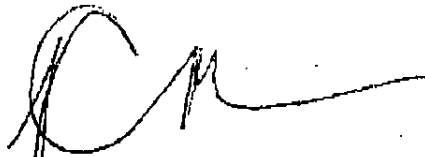

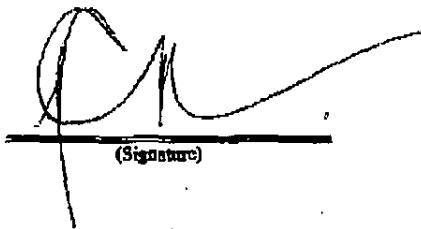
