**ARTICLE III - Management**





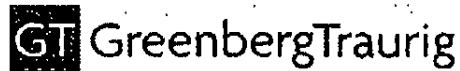
