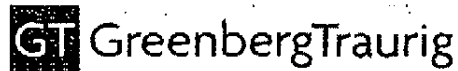

**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF

FIRST: The name of the Limited Liability Company is Pablo Cosentino, LLC (the "Company"), the initial Articles of Organization of which were filed on May 31, 2011, and assigned document number L11000063571.
