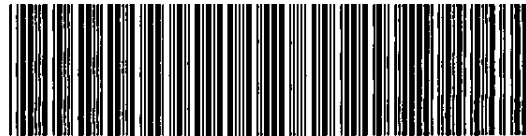

**ARTICLES OF AMENDMENT TO THE**  
**ARTICLES OF ORGANIZATION OF**  
**NY CAFE, LLC**

The Articles of Organization for NY CAFE, LLC, were filed on June 1, 2011 and assigned Florida Document Number L11000063969, and are hereby amended as follows:

1. Article VII is hereby amended as follows:

**ARTICLE VII**

**PROFITS AND LOSSES**

(A). Profit Sharing. The members shall be entitled to the net profits arising from the operation of the limited liability company business that remain after the payment of the expenses of conducting the business of the limited liability company. Each member shall be entitled to the distributive share of profits specified as follows:

JOHN SPIERING	20%
SARAH SPIERING	80%

The distributive share of the profits shall be determined and paid to the members each year on or before the forty-fifth day following the closing of the business' fiscal year.

(b). Losses. All losses that occur in the operation of the limited liability company business shall be paid out of the capital of the limited liability company and the profits of the business, or, if these sources are insufficient to cover such losses, by the members in shares equal to their percentage of ownership.

The undersigned, being the members of the limited liability company, hereby ratify, approve and consent to these Articles of Amendment to the Articles of Organization of NY CAFE, LLC.
