4.02. **Name and address.** The name and address of the initial member of the limited liability company is Jeff Allan, 2131 Westover Drive, Panama City, FL 32405.


4.03. **Membership ratio/responsibility.** The managing member is responsible for all management decisions and/or actions.

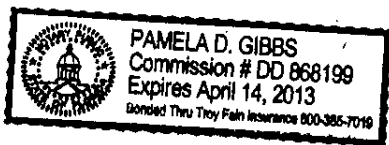
