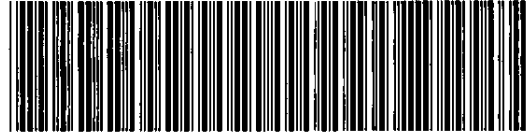

The undersigned, for the purpose of forming a limited liability company for profit under Chapter 608 of the Florida Statutes, adopts the following Articles of Organization:

ARTICLE I – NAME

Section 1.1. The name of the limited liability company shall be KARIN H. VANGURA, M.D., LLC.
