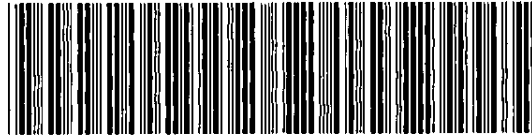

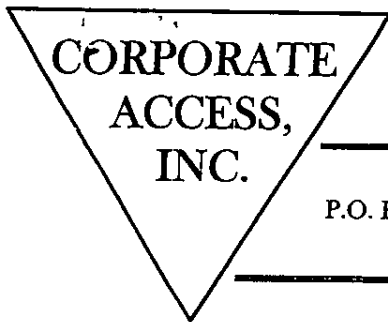

FOURTH: The mailing address and street address of the principal office of the Limited Liability Company is 8925 Heritage Bay Circle, Orlando, FL 32836.


