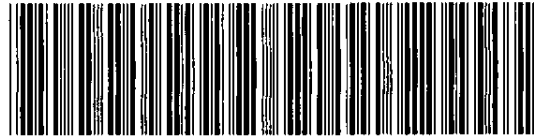

ARTICLE IV — PURPOSE:


