The following Articles of Merger are being submitted in accordance with Sections 607.1105 and 605.1025 of the Florida Statutes:

FIRST: Arluck Promotions, Inc. (the "Merged Corporation") is merging with and into Fitter & Faster Tour LLC (the "Surviving Company"), with the Surviving Company being the surviving party, pursuant to an Agreement and Plan of Merger (the "Merger"). SIXTH: The Surviving Company has agreed to pay to any members of any limited liability company with appraisal rights the amount to which such members are entitled under the provisions of Florida Statutes Sections 605.1006 and 605.1061 - 605.1072.
