

ARTICLES OF ORGANIZATION OF WILLIAM ROYCE SMITH, P. L.L.C.

The undersigned, pursuant to the provisions of Chapter 621 of the Florida Statutes (the "Professional Limited Liability Company Act"), for the purpose of forming a Professional Limited Liability Company under the laws of the State of Florida, does hereby set forth the following:


